# Terms and Conditions MPT Device Collaboration Promotions

By participating in the MPT Device Collaboration Promotions ("Promotion"), you signify that you have read, understood, and agree to be bound by these Terms and Conditions and any other applicable rules, policies and terms associated therewith (collectively, the "Terms"). The Promotions are provided to you by vivo Mobile Myanmar Co., Ltd (vivo smart phones), real Trading Co., Ltd (realme smart phones), Unlimited Co., Ltd (Samsung smart phones), Myanmar Unison Technology Services Co., Ltd (Huawei smart phones) and BF Science and Technology Co., Ltd (OPPO smart phones) with the support of Myanma Posts and Telecommunications ("MPT", "we", "us", "our").

The Terms are subject to change at any time. Your continued participation in the Promotion after any such change constitutes your acceptance of the revised Terms.

#### 1. The Promotion

- 1.1 The Promotion is intended solely for customers who are (i) at least eighteen (18) years of age or have obtained the consent of a parent or legally recognized guardian; and (ii) have the power and capacity to enter and be bound by the Terms.
- 1.2 You will receive device promotion bonus (E.g., 2GB and 200 minutes (on-net) per month for six (6) months) ("**Bonus**") when you purchase a promotion campaign smart phones (E.g., vivo V25 or Huawei Nova 10 or Samsung Galaxy Z Fold 4) during the Promotion Period and use it with an MPT SIM card and top up **at least (1 time)** pre-defined amount (E.g., MMK 3,000 or 5,000 or 10,000) per month continuously for six (6) months from date of purchase.
- 1.3 The Promotion period is normally one year, and it varies based on each promotion ("**Promotion Period**").
- 1.4 The Bonus must be taken as stated and no compensation will be payable if the participant is unable to use the Bonus.
- 1.5 The Bonus is non-transferrable and not convertible to cash.
- 1.6 All rights not expressly granted to you under the Terms are reserved and retained by us or our licensors, suppliers, publishers, rights holders, or other content providers. You may participate in the Promotion only as permitted by the Terms and by law; all other uses are strictly prohibited.
